


# **A FAIR ASSESSMENT?**

Musculoskeletal conditions: The need for local prioritisation.* It sets out the detailed findings of our research for that report, in which we analysed the Joint Strategic Needs Assessments and Joint Health and Wellbeing Strategies of every local authority with a statutory duty to produce these documents. These documents were sourced between 17th February 2014 and 7th March 2014.
